Outdoor Learning Day is a learning activity and therefore full attendance is required. **For causal leave, prior approval from the school is required. A medical certificate is required for sick leave. Any students who fail to comply with this rule will be treated as truancy.**

To facilitate the activity and ensure safety, students should follow rules under our instructions. Parents are cordially invited to inform your child(ren) of the following measures:

- (1) To be considerate. Students should be self-disciplined and behave themselves during the activity.
- (2) Students should not take part in any water activities, swimming, rowing, fishing, rock climbing, caving, cycling, etc.
- (3) Students should obey orders from the teacher and stay in designated areas. They should not leave the group during the activity.
- (4) If there is an accident, students should report to the teacher immediately.
- (5) Students should follow the traffic arrangements given by teachers.
- (6) When it is about time to leave, students should return to the rally point on time. If a student arrives at the rally point after the class has left due to some special reasons, he/she should stay at the rally point and wait for the teacher.

For teachers to recognise students and for safety reasons, the school has the following guidelines on clothes:

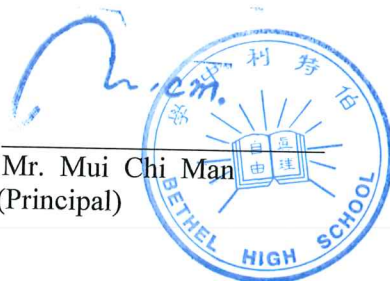
**** If a student violates the guidelines on clothes, he/she must stay behind in school instead of joining the activity.**

2. Pants

 - Sport shoes (Mainly white; must have socks)
4. If new students have no such sport uniforms, students must wear Blank Sport Long Pants and Tops of School summer sportswear to attend the activity.
